## **CONFIRMATIONS**

## **AWARDS**

First through Fourth place ribbons will be awarded for each jump height in Novice, Open and Elite classes in both the Proficient and Skilled categories. Qualifying ribbons will be awarded for each qualifying run. There are no placements for Chances - only qualifiers. There will be special prizes for anyone earning a NATCH at this trial.

## **MOVE UPS**

We will accept move-ups or changes in writing only (email ok) to your entry until 5:00 PM on May 2, 2018.

## **DAY-OF-SHOW ENTRIES**

If we do not reach our limit, we may offer day-of-show entries. The cost will be \$12 per run with no package deals allowed.

## **REFUNDS**

A 100% refund will be given for any requests for withdrawals received prior to the Closing Date. A 75% refund will be given for bitches in heat, injured or ill dogs (with verification from a vet upon request), injured handlers (with verification from a doctor upon request) or family emergency. There shall be no refunds for entries withdrawn after the closing date or in the event a dog and/or handler are dismissed from competition, regardless of the reason for such dismissal.

## **DOG REGISTRATION NUMBERS**

You will need to register your dog(s) with NADAC. Dogs can be registered on-line at the NADAC web site at [www.nadac.com](http://www.nadac.com) (click on "Dogs" on the Home Page and then on "Dog Reg. Form").

## **EQUIPMENT**

Slatless contacts will be used. The A-frame and Dog Walk have rubber surfaces.

Weave poles have 24" spacing.

Electronic timers will be used.

## **VETERAN DOG RULE**

As of January 2014: Dogs must enter the Veterans Division after their 9th birthday.

Dogs must enter the Skilled Category, Veterans Division after their 12th birthday.

## **ENTRY RULES**

We will accept entries starting March 26, 2018 or later until the limit is reached or the *Closing Date*. If the limit is reached before all entries bearing the same postmark date have been accepted, priority for available spots will be given to a limited number of exhibitors who volunteered to work. Incomplete or inaccurate forms will NOT be accepted. No hand deliveries, please. Do NOT send an entry that requires a signature. If you use express mail, check the box "*Signature Waived*". Entries received earlier than *Opening Date* will be returned unopened.

## **NADAC TREATS RULE**

NADAC allows handler to carry treats during a run if the treats are secured in a sealed container that is not visible to the dog, the judge or other exhibitors. If a container or a sealed bag falls out during a run it is not grounds for elimination unless the judge of record believes there is unethical behavior involved.

## **DIRECTIONS TO ADAMS COUNTY FAIRGROUNDS**

### **9755 Henderson Rd., Brighton, CO 80601**

**From the South:** Take I-25 North to the I-76 W/I-76 E exit toward 70th Ave/Grand Jct/Fort Morgan

Take exit 216A to merge onto I-76 E toward Ft Morgan

Take exit 12 on the left to merge onto US-85 N toward Greeley/Brighton

Turn left at E 124th Ave/CO-22

Continue on Henderson Rd – Fairgrounds will be on the right

Turn right into the regional park and follow the road past the lake.

We will be in the northern most grassy field on the right side.

Unloading will be allowed by the field, but main parking is on the west side of the main road.

**From the North:** Take I-25 South to 136<sup>th</sup> Ave (exit 225).

Head East (left) onto 136<sup>th</sup> Ave to Holly Street.

Turn right (south) onto Holly Street.

Turn left onto 128<sup>th</sup> Ave. Follow 128<sup>th</sup> Ave to the "T" intersection/stop sign.

Turn right onto Riverdale road and take the next left onto Henderson Road.

Follow Henderson Road to the fairgrounds on the left just past the museum.

Turn left into the regional park and follow the road past the lake.

We will be in the northern most grassy field on the right side.

Unloading will be allowed by the field, but main parking is on the west side of the main road.

OR

Take I-25 South to E-470 – Exit 228 (toll road - using license plate billing).

Go east on E-470 to Hwy 85 – Exit 38.

Head south on Hwy 85 to E 124<sup>th</sup> Ave.

Turn right onto E 124<sup>th</sup> Ave. Go straight at the stop sign @ Brighton Blvd. You will now be on Henderson Blvd.

Go approx .3 miles and turn right into the regional park and follow the road past the lake.

We will be in the northern most grassy field on the right side.

Unloading will be allowed by the field, but main parking is on the west side of the main road.

## NADAC RULES AND REGULATIONS

This trial will be held under the current rules and regulations of NADAC. By entering this trial, the exhibitor is representing that he/she is knowledgeable of NADAC's rules. Exhibitors Handbooks are available free of charge by downloading from NADAC's web site at [www.nadac.com](http://www.nadac.com).

### SKILLED AND PROFICIENT CATEGORIES

**A dog may be entered in one category, Skilled or Proficient, per weekend.** A dog may not be entered in Skilled one day and Proficient on another day. Dogs may enter the Skilled or Proficient category in the Standard, Veteran, or Junior Handler Division. **Note: When entering the Skilled Category, all dogs must jump 4" lower than their Proficient, Standard Division jump height requires.**

Dogs are allotted the standard course time for, and are scored and placed in the jump height entered.

Dogs may have up to five course or time faults and still receive a 5 pt. qualifier toward their Regular Agility title. All other classes require that you have a clean run, with no course or time faults to earn a Q.

### VETERAN/DISABLED HANDLER

Non-Jumping Classes—Veteran or Disabled Handler. Handlers who are 60 years or older, or who have a disability that restricts mobility, may choose to enter the non-jumping classes as a Veteran Handler and receive 10% more standard course time. This option is for Veteran/Disabled handlers in the non-jumping classes only.

The Veteran/Disabled Handler division is designed for handlers who, due to age or impairment, are mobility limited and need extra time to guide their canine partners through an agility course.

When entering as a Veteran/Disabled Handler, you must enter all dogs in all classes for the entire trial in this Division and must jump 4" lower than your Proficient, Standard Division jump height requires. In the non-jumping classes, dogs will be scored and placed with their Standard Division jump height.

### MEASURING

#### Dogs which require measuring:

Dogs in the Proficient Category, Novice, Open or Elite jumping 4", 8", 12" or 16"

#### Dogs which do not need to be measured:

Dogs jumping 16" in the Veteran or Junior Handler Division  
 Dogs jumping 20"  
 Dogs in the Skilled Category  
 Dogs with a permanent height card  
 Dogs listed on the Height Exemption List

### JUMP HEIGHTS

There are four Standard Division-Proficient jump heights: 8", 12", 16", and 20".

There are four Standard Division-Skilled jump heights: 4", 8", 12", and 16".

There are four jump heights for the Veterans and Junior Handler divisions: 4", 8", 12", and 16".

Please see the NADAC Rulebook for the full jump height table.

**IMPORTANT.** Please check your dog's NADAC registration number on your trial confirmation as soon as you receive it; also, please check the copy of the results posted at the trial. You should report any errors to the Trial Secretary immediately.

NADAC records trial results as they are submitted by the host clubs/groups. The individual trial results submitted by the club are uploaded to the [www.NADACForum.com](http://www.NADACForum.com) within two weeks after the NADAC office receives them from the club. Please accept the responsibility to review those results, and check that your registration number and qualifying points, as reported by the club, are correct. You can join the Forum by going to [www.NADACForum.com](http://www.NADACForum.com) and submitting your request. If you find an error in the reporting of your dog's qualifying points or registration number, please contact the host club. The host club is responsible for correcting any errors and informing NADAC.

**Levels.** Points earned at a higher level of a class, prior to the completion of the lower level title, will not be recorded by NADAC for future use. If a dog earns points in a level of a class that they are not eligible to title in, those points will not be added to the dog's records.

#### **NOTICE TO EXHIBITORS**

Below is a brief summary of NADAC rules. Please refer to [www.nadac.com](http://www.nadac.com) for a full explanation of all NADAC rules and up to date information.

- Please note that NADAC trials should provide a safe and fun environment for both exhibitors and their dogs.
- Aggressive dogs will not be tolerated and will be excused from the trial.
- The show committee has the right to refuse any entry. Anyone not currently in good standing with NADAC will not be allowed to enter this trial.
- Exhibitors, through submission of entry, acknowledge that they are knowledgeable of NADAC rules and regulations, and agree to abide by all rules in effect at the time of this trial.
- No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- Checks not honored by the bank do not constitute a valid entry fee. There will be a \$25.00 service charge for bank returned checks.
- \*\*Dog must be registered and have a valid registration number before entries will be accepted.

- Bitches in heat, lame, or blind dogs are ineligible for entry, as is any dog with a deformity which may cause a judge to not be able to reasonably assess the dog's ability to function and perform agility obstacles safely, and in a manner that is in the best interest, health and welfare of the dog.
- No collars, leads, food, toys, clickers, or other aids or devices shall be permitted on the course or within ten feet of the ring entrance at any time. All dogs should be on leash when not competing.
- The sponsoring clubs will not be responsible for the loss or damage to any dog exhibited, or for the possessions of any exhibitor whether the result be accident or other cause. It is distinctly understood that every dog at this event is in the care and control of his owner or handler during the entire time the dog is on the show premises.

## **AGREEMENT**

The person who signs this agreement represents that he/she is authorized to enter into this agreement on behalf of both exhibitor and the owner of entered dog. In consideration of acceptance of this entry:

- 1.1. As used here "NADAC" means the North American Dog Agility Council, LLC., its members, officers, directors, employees, show chairs, show committees and agents.
- 1.2. Exhibitor/owner agree to abide by the rules and regulations of NADAC and any other rules and regulations appearing in the premium for this event.
- 1.3. Exhibitor/owner certify that the entered dog is not a hazard to persons, dogs or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.
- 1.4. Exhibitor/owner acknowledge all hazards presented by the event and the event premises, including, but not limited to, the condition of the surface, restrooms, security measures or lack of, electrical appliances, fittings, show rings, parking areas and the presence of unfamiliar animals and people; exhibitor and owner assume the risk of any harm arising from these.
- 1.5. Exhibitor/owner releases NADAC (including its respective officers, directors, employees, and members), Mountain Dog Sports LLC (including its officers, directors, members, and event organizing committee), and Adams County Regional Park (including its officers, agents, and employees) and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises. Without limiting the generality of the foregoing hold harmless provisions, exhibitor/owner hereby specifically assumes sole responsibility for and agrees to indemnify and save the aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this event, howsoever such injury or death may be caused and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons.
